FENCING/ENCLOSURE REQUIREMENTS (LOCAL LAW 7 AND LOCAL LAW 4)

It is the owner's/keeper's responsibility to provide adequate fencing or an enclosure on their property to effectively prevent the animal from leaving or escaping the premises. Consideration should be made to ensure adequate freedom for exercise and protection from the elements, having due regard in both matters to the breed, size and nature of the dog or cat.

- To receive a discount on your registration, provide a copy of your current pension card and/or a copy of the proof that your pet is desexed. If returning this form by mail, please also include payment.
- If paying at the Council office, a tag will be issued to you at time of payment. If forwarding the form by post, a tag will be posted to you.
- If you wish to pay by credit card and forwarding the completed form by post, please complete credit card details below.
- No more than two (2) dogs may be kept on a property unless that property is over 2,000m². If the property is over 2,000m² up to four (4) dogs may be kept. If you wish to keep more than these amounts you can apply for a permit.¹
- No more than two (2) cats may be kept. If you wish to keep more than this amount you can apply for a permit.¹
- Only the animal's owner can access or modify the animal's records.
