4.	Indigenous Australian Soldier War Memorial	An indigenous memorial is being considered for the Ipswich area to represent the people who went to war from the Ipswich area. The Indigenous Land Use Partnerships Coordinator attended the meeting and will be consulting with the Traditional Owners to determine suitable locations. A working group will be formed. Further discussion will be held at the next meeting in regard to details of wars to be included. Action: Indigenous Land Use Partnerships Coordinator will forward a flow chart (on the process) to Strategic Planning and this will be emailed to Committee Members.

5. Correspondence	(a) Letter received from Eastern Suburbs Anzac Day Commemoration Committee Incorporated dated 2 June 2017. This was received by Cr Wendt (Division 5 Councillor). They believe there are many names missing from the memorial and some corrections needed. They wish to remove the western marble panel and replace it with a new panel with the correct information. Cr Wendt was asked to assist in getting approvals so they could proceed with stonemason quotes etc. As the memorial is on the Queensland Heritage Register, the Department of Environment and Heritage Protection were contacted for advice. They advised that the original memorial should not be altered and that an alternative should be sought. Cr Wendt has responded to the letter from the Eastern Suburbs Anzac Day Commemoration Committee providing the advice from DEHP.
	(b) Letter received from Ipswich Historical Society dated 17 June 2017. The Society advised that an exhibit will be launched in April 2018 to recognise the contribution of Ipswich service men and women, families, and manufacturers to the war effort in the Great War 1914-1918. The patriotic activities of families on the home front will form part of the exhibit. They are asking to borrow or copy letters, diaries, personal items or memorabilia for the exhibit.
6. General Business	(a) Railway Sub-branch – grant for 2 nd stage has ensured paving at the rear has been completed. Works proposed for Stage 3 will require funding. The Chairman of the Monuments and Memorials committee requested that an email be sent to him from the Railway Sub-branch regarding the funding requirements.
	(b) Responsibility for the plaque (for trees in memory of the miners who died in Box Flat disaster) was discussed. Action: The Chairman will follow up with the government body responsible for the plaque.
	(c) Historical Markers – it was proposed that a 5 year program plan should be prepared for historical markers.
	(d) It was suggested that the definition for 'monument' and 'memorial' be provided to the Committee at the next meeting.
	(e) The Chairman requested that a marker or plaque be considered for Cora Lyn (legacy flats for war widows) on Glebe Road, Ipswich.
