# Introduction

Council's Department of Infrastructure Services (IS) is the lead service provider in the Ipswich community for the planning and delivery of the city's transport and municipal capital infrastructure. This includes Strategic Transport and Investment Planning, Program Development, Traffic Engineering and Road Safety Advice, Program Management, Design and Survey, Procurement, Project Management and Construction.

The IS Department's activities are delivered through its four (4) Branches:

- Infrastructure Planning, comprising of:
  - o Transport Planning
  - o Infrastructure Planning
  - Management of Customer Service Requests related to transport, traffic and local drainage
  - o Manage and operate the traffic signal network and intelligent transport systems
- Program Management and Technical Services, comprising of:
  - Program Management and Coordination Section (Pre-Tender Management)
  - o Technical Services Section (Design, Survey, Geotech)
- Construction, comprising of:
  - o Transport Delivery
  - o Municipal Works Delivery (Open Space, Drainage, Facilities, Divisional works)
- Business Support, comprising of:
  - o Contracts and Procurement
  - o Performance and Controls
  - o Estimation
  - o Scheduling



# **Capital Portfolio**

### **Progress Summary**

The 2018-2019 Master Schedule performed well against the Master Schedule for the period. IS has completed 57 projects to date in 2018-2019, out of approximately 372 construction projects.

There are 180 projects carried over from the 2017-2018 financial year to be completed this financial year, of which 150 projects are reseal projects. These are included in the 372 construction projects. The 150 reseal projects are planned to be completed by late November 2018. Seven (7) carryover projects completed so far this financial year.



### **Cost Summary**

The carryover budget from 2017-2018 FY was adopted in October 2018 in Budget Amendment BAV#1. The total available budget for 2018-2019 FY for the capital portfolio is \$82.23 million.

# Planning

The recommended actions outlined in iGO, continue to be progressed; including strategy and policy development, investment and corridor planning, grant applications, project scoping, feasibility and provision of transport and traffic advice.

**Norman Street Bridge Preliminary Business Case** – (iGO Action R9). The Preliminary Business Case to "Address Congestion, Cross River Connectivity and Network Resilience in the Ipswich City Centre" is in progress with technical analysis and traffic modelling of the two recommended options underway. The preliminary business case is scheduled for completion in December 2018.

**10** Year Transport Infrastructure Investment Plan (10 Year TIIP) – (iGO Action D8). The 10 Year TIIP provides intelligence for logical and effective program management and the delivery of major transport projects including effective planning, design, procurement, pre-construction and construction processes. The annual revision of the plan is in progress and the draft version has been aligned to the 2018-2019 capital portfolio.

**iGO Public Transport Advocacy and Action Plan** – (iGO Action PT7). This project will identify short, medium and long term improvements to the public transport system and advocacy strategies. The consultants draft report will be circulated for internal review in November 2018.

**iGO Parking Pricing Strategy** – (iGO Action P6). The project will identify short, medium and long term pricing actions, technologies, zones, pricing models etc. to effectively manage short and long stay parking arrangements in the Ipswich City Centre. The project has commenced with the initial background research underway. Request for quotation (RFQ) for the parking survey is complete with award scheduled late October 2018. The RFQ process to engage a consultant for the Parking Pricing Strategy will commence November 2018.

**TMR Cycle Network Local Government Grants** – (iGO ATAP Action 1.3). Early project identification work for the 2019-2020 cycle grant applications is underway. The proposed project list for the cycle grant applications is planned to be submitted to Council in November 2018 for endorsement.

**iGO** Active Transport Way Finding Strategy – (iGO Action AT5 and iGO ATAP Action 6.1). The project involves the development of an active transport signage strategy and signage design guide. The final strategy and design manual was endorsed by Council at the October 2018 Committee.

**iGO** Intelligent Transport Systems Action Plan – (iGO Action R5). The project involves the development of a strategic plan for road based technologies. The final draft report has been received from the consultant and is being reviewed by Council officers. The final report will be submitted to Committee early 2019 for endorsement.

**Deebing Creek Bikeway Corridor Plan** – (iGO Action AT9 and iGO ATAP Action 1.4). A corridor planning study for a new bikeway along Deebing Creek between Carr Street (Ipswich) and the Cunningham Highway (Yamanto/ Flinders View). Hydraulic analysis and preliminary cost estimation work are in progress. A draft report from the consultant is expected late October 2018.

**Annual Strategic Traffic Count Program** – (iGO Action D14). The program involves the placement of traffic (tube) counters at 105 sites across the city for a period of at least seven days. The data assists Council with its transport planning, traffic operations, road maintenance, investment programming and development assessment activities. The count program will run from mid-October to late November 2018.



# **Schedule**

### **Key Capital Project Updates**

- Rosewood Library The Construction Package is being prepared by the Consultant and the Building Approval has been submitted. Procurement for the building works will commence with Tender release after the Building Approval is received. Approval has been received from the State Government for the grant fund extension to the 31 December 2019 with the condition the building works are also completed before this time.
- 2017 2018 Road Resurfacing Program Construction works are complete in Divisions 10 (Package 1), 9 and 8. Division 7 has one street to complete, this will occur in November 2018 (weather permitting). Spray seal works have commenced in Divisions 3, 4 and 5 though currently behind schedule due to inclement weather. All pavement repairs now completed. Works Request Form for Division 10 (Package 2) has been issued to the Asphalt Supply Panel and currently under review for approval. Works are scheduled to commence late November 2018.
- Kerb and Channel (K&C) Program Sixteen projects are to be delivered in 2018-2019. Detailed designs have been completed for all 16 projects and all are ready for construction. 2 K&C projects are complete and 2 are in construction.
- Redbank Plains Stage 3 Detailed design is progressing, with the focus on minimising the impacts on private properties and increasing usability for all road users – motorists, cyclists and pedestrians. It is anticipated that the first detailed design milestone will be reached early November 2018.
- Old Toowoomba Road, Leichhardt Property resumptions are to be finalised. Relocation of major services are progressing. The Tender for the civil construction works has been released to market and closes on the 31 October 2018. APA has submitted their design for the gas relocation with IS comments provided to APA.
- Brisbane Street, West Ipswich Property resumptions are now finalised. Relocation of major utilities is progressing with 2 of 5 service providers completing their service relocation. The civil works Tender Evaluation Report will be submitted to the November Council meeting for approval, with the civil works scheduled to commence in January 2019.
- Blackstone/South Station Roads Intersection upgrade All service relocations with the exception of the traffic cameras are complete. The Tender Evaluation Report was approved at the October 2018 Council meeting, with civil works scheduled to commence November 2018.
- Marsden Parade realignment The environmental (contamination) report regarding 53 Brisbane Street (formerly a service station) has been finalised. All land acquisitions are complete and discussions are progressing with the affected tenant at 55 Brisbane Street to vacate the property. Stage 1 (enabling works) is scheduled to commence in the last quarter of 2018.
- Limestone Park Detention Basin Works are progressing, with completion scheduled late December 2018.
- Western Ipswich Bikeway Link Detail design is scheduled for completion at the end of October 2018. Property resumptions are nearing finalisation and required service relocation works confirmed. Pre-construction works are scheduled to commence in December 2018.

#### **INTRODUCTION:**

This is a report by the Senior Transport Planner dated 15 October 2018 concerning the Queensland Government Department of Transport and Main Roads 2019-2020 Cycle Network Local Government Grants Program.

#### BACKGROUND:

The Queensland Government is committed to achieving the *Queensland Cycling Strategy* 2017-2027 vision of 'more cycling, more often'.

The Cycle Network Local Government Grants Program (CNLGGP) provides a mechanism for the Queensland Government, through the Department of Transport and Main Roads (DTMR), to work closely with councils to achieve this vision by delivering and improving principal cycle networks across Queensland.

DTMR has now invited local governments to submit applications under their 2019–2020 CNLGGP. Applications close on 21 December 2018 with successful projects announced in June 2019 as part of the *Queensland Transport and Roads Investment Program*.

#### PARAMETERS:

The objective of the grant program is to deliver high quality and safe cycling facilities on principal cycle routes across Queensland.

Generally, Council can apply for a maximum 50% grant funding for the design and/or construction of a project over two financial years that contributes towards the delivery of the principal cycle network outlined in the 2016 South-East Queensland Principal Cycle Network Plan (refer Attachment A).

The parameters for the 2019–2020 CNLGGP are outlined in Table 1 below.

 2019-2020 Cycle Network Local Government Grants Program Parameters

In addition to the standard grant project funding, in 2019-2020 DTMR is also offering four additional special grant categories. These are outlined below:

- One Network Projects One Network Projects are those which demonstrate that Council and the TMR district have collaborated strategically to deliver a principal cycle route with consistent design standards on both the local and State-controlled road network. These projects will be considered favourably during the assessment process.
- Infra+ Projects Infra+ Projects is a funding initiative available to Council to undertake targeted promotion, engagement, behaviour change and educational activities associated with recent cycling infrastructure that has been delivered on the principal cycle network through the CNLGGP.
- **Priority Design Treatments** TMR is offering councils the opportunity to access 100% grant funding towards the <u>design</u> element of projects that will deliver cost effective on-road physical separation devices or advisory lanes. A maximum of 50% grant funding still applies to the construction of these facilities.
- Highest Priority Route Options Analysis TMR is offering Councils 50% grant funding to undertake options analysis of Highest Priority Routes in order to develop a pipeline of quality projects for delivery on locally-controlled portions of the principal cycle network. Projects are funded for one financial year.

#### ASSESSMENT PROCESS:

All eligible applications are prioritised by DTMR through a rigorous three stage assessment process, including;

- 1. A multi-criteria analysis against the criteria outlined in Table 2 (over);
- 2. A technical assessment of the project eligibility and constructability; and
- 3. A panel assessment using the information gathered from the previous assessments to prioritise the projects and provide a final recommendation for departmental approval.

Of particular importance, the 2019-2020 Program Guidelines identify that projects which <u>are</u> <u>not</u> on a Highest Priority Route, as per the *2017 South-East Queensland Principal Cycle Network Plan Priority Route Maps* (refer Attachment B), will score significantly lower in the assessment process.

FUNDING CRITERIA	DESCRIPTION
Strategic Priority	Project is on a Highest Priority Route identified in the Priority Route Maps and Action Plans for the Principal Cycle Network.
Attractiveness and Comfort	Project creates a safe and secure environment for vulnerable and new cyclists of all ages and abilities.
Network Enhancement	Project contributes to the delivery of the principal cycle network, particularly filling gaps/ missing links in the network and addressing barriers to cycling on the network.
Connectivity	Improving the connectivity of the cycle network, linking the community to key local trip attractors.
Demand	Projects are adequately designed to accommodate the surrounding population level, considering both current and future population projections (10 years).
Safety Improvement	Project improves safety to cyclists, addressing risks, known hazards and crash locations.
Cost Effectiveness	Project costs are appropriate to project scope and are value for money.
Project Feasibility and Deliverability	Project can be delivered within required timeframes and has adequately addressed relevant project obstacles.

#### **PROPOSAL:**

Taking into account the program parameters and assessment processes outlined above, Council's cycling priorities outlined in the *iGO Active Transport Action Plan* and *10 Year Transport Infrastructure Investment Plan* and the level of concept planning currently available for projects on the principal cycle network, it is proposed that Council apply for the projects outlined in Table 3 (over) as part of the 2019–2020 CNLGGP.

With regard to the four special grant categories:

- **One Network Projects** Council officers have engaged with the DTMR Metropolitan district regarding potential combined projects and have determined that Council and DTMR are not in a position to apply for joint grant funding this year.
- Infra+ Projects Projects of this grant type are typically delivered by the Works, Parks and Recreation Department and as such, will be addressed as part of a separate committee report to Council.
- **Priority Design Treatments** Council officers have reviewed available bicycle planning relating to the priority design treatment grant opportunity and identified that there are no projects at an eligible stage to apply for this type of grant funding.

• **Highest Priority Route Options Analysis** – Council officers have reviewed future bikeway planning priorities and while there are eligible projects for this grant category, the financial benefit of the grant is not considered to outweigh the extra works and approvals required by the grant.

#### CONCLUSION:

The Queensland Government has invited local governments to submit applications under their 2019–2020 Cycle Network Local Government Grants Program to design and construct high quality cycling facilities on the principal cycle network.
