

PENSIONER RESOURCE RECOVERY CENTRE DISCOUNT

From 1 July 2025, eligible pensioners can access a 20% discount when disposing of waste at Ipswich's Resource Recovery Centres (Riverview and Rosewood).

To receive the discount, eligible individuals must:

- attend a Resource Recovery Centre in person
- provide council staff with eligible proof of pensioner status.

The discounted fees apply only to non-commercial, domestic waste loads.

General Waste fee: \$17.00* for up to 500kg

Green Waste fee: \$11.00* for up to 500kg.

* for 2025-2026 financial year.

Standard fees and charges apply to waste over 500kg.

ELIGIBILITY REQUIREMENTS

Eligible proof of pensioner status includes:

- Age Pension
- Carer Payment
- Disability Support Pension
- Parenting Payment Single
- Widow Pension
- Wife Pension
- Service Pension
- War Widow Pension with full income support supplement.

ACCEPTED CARD TYPES



Holders of Seniors Cards, Health Care Cards, Health Benefit Cards and Repatriation Health Cards for specific conditions are not eligible.

The Riverview Resource Recovery Centre can accept a restricted quantity of household and lead acid batteries. ALDI, Coles, Woolworths, Total Tools, The Good Guys, Battery World, Bunnings Warehouse and B-cycle have recycled batteries programs. Batteries disposed of incorrectly are at risk of catching fire.

1. WASTE DISPOSAL AT RESOURCE RECOVERY CENTRES

1.1 Riverview Resource Recovery Centre (only)



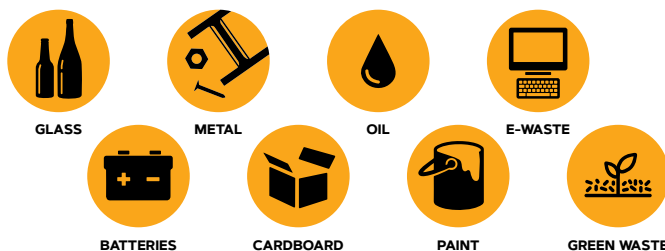
Domestic household waste and recycling (Ipswich residents only - proof of residency required)

The approved recyclable materials listed below can be accepted at no charge at the Riverview Resource Recovery Centre, provided no other waste material is in the load. These materials are to be separated and placed in the respective collection areas.

- approved recyclables, including:
 - scrap metal
 - vehicle batteries
 - cardboard
 - e-waste
 - motor oil (maximum of 20 litres from domestic sources only).
- household co-mingled recycling materials
- paint and eligible products accepted through the Paintback scheme, in accordance with the limits specified in the Paintback scheme.

1.2 Rosewood Resource Recovery Centre (only)



Note: Commercial vehicles and oversized trailers are not accepted at Rosewood.

Domestic household waste and recycling (Ipswich residents only - proof of residency required)

The approved recyclable materials listed below can be accepted at no charge at the Rosewood Resource Recovery Centre, provided no other waste material is in the load.

These materials are to be separated and placed in the respective collection areas.

- approved recyclables, including:
 - scrap metal
 - vehicle batteries
 - cardboard
 - motor oil (maximum of 20 litres from domestic sources only).
- household co-mingled recycling materials.
- paint and eligible products accepted through the Paintback scheme, in accordance with the limits specified in the Paintback scheme.

1.3.1 Tyre Disposal

Disposal of passenger tyre (per tyre)	\$11.30
Disposal of passenger tyre including rim (per tyre)	\$17.30
Disposal of 4WD tyre (per tyre)	\$13.50
Disposal of 4WD tyre including rim (per tyre)	\$23.50
Disposal of light truck tyre (per tyre)	\$17.30
Disposal of light truck tyre including rim (per tyre)	\$24.60
Disposal of bicycle tyre with or without rim (per tyre)	\$2.60

1.3.2 Non-Ipswich Residents / Commercial / Industrial Waste

Note: Commercial operators are permitted to dispose of the following items free of charge:

- paint and eligible products accepted through the Paintback scheme, in accordance with the limits specified in the Paintback scheme.

General waste: First 300kg or part thereof	\$79.00
General waste: Excess over 300kg (per kg)	\$0.30
Green waste: First 500kg or part thereof	\$74.00
Green waste: Excess over 500kg (per kg)	\$0.22

1.3.3 Domestic household waste and recycling (Non-Ipswich residents)

General waste: First two (2) cubic metres or part thereof	\$79.00
General waste: Excess over two (2) cubic metres or part thereof	\$40.00
Green waste: First two (2) cubic metres or part thereof	\$74.00
Green waste: Excess over two (2) cubic metres or part thereof	\$37.00

1.4 RRC Deferred Payment fees
