# IPSWICH CITY COUNCIL LOCAL LAW POLICY NO. 17 - PARKS AND RESERVES

### Citation

1. This local law policy may be citied as Local Law Policy No. 17 (Parks and Reserves).

### Objects

- 2. The objects of this local law policy are to provide detailed information called upon by Local Law No. 17 (Parks and Reserves) to -
  - (a) provide for the establishment of parks and reserves on land under the local governments control; and
  - (b) provide for appropriate public access to parks and reserves for active and passive recreation; and
  - (c) protect the safety of persons using parks and reserves; and
  - (d) preserve features of the natural and built environment and other aspects of the amenity of parks and reserves; and
  - (e) regulate activities in parks and reserves and ensure appropriate standards of conduct.

### Local Law - section 5(1)

- 3. For the purposes of section 5 (1) any land designated as park will be detailed in the register titled 'Parks and Open Space within Ipswich City'. This register will contain the following information, be open to inspection by the public and amended in accordance with the relevant procedure as adopted from time to time:
  - Name
  - Address/Location
  - Property Description
  - Area

### Local Law - section 5(2)

- 4. For the purposes of section 5(2) any land designated as reserve will be detailed in the register titled 'Reserves and Conservation estate within Ipswich City'. This register will contain the following information, be open to inspection by the public and amended in accordance with the relevant procedure as adopted from time to time:
  - Name
  - Address/Location
  - Property Description
  - Area
  - Electoral Division

### Local Law - section 6

5. Pursuant to section 6 of the Local Law the boundaries of all parks/reserves are detailed within the registers titled 'Parks and Open Space within Ipswich City' and 'Reserves and Conservation Estate within Ipswich City'.

### Local Law - section 7

6. For the purpose of section 7 of the Local Law the parks/reserves shall be named as detailed in the registers titled 'Parks and Open Space within Ipswich City' and 'Reserves and Conservation Estate within Ipswich City'.

## Local Law - section 8 (1)

7. For the purposes of section 8(i) of the Local Law, all parks and reserves shall be open to the public at all times except for the following parks and reserves which shall only be open to the public during the times specified:

Name of park or reserve	<i>Times that park or reserve is open to the public</i>
(i) Kholo Gardens	Sunrise until Sunset
(ii) Pan Pacific Peace Gardens	Sunrise until Sunset
(iii) Colleges Crossing Recreation Reserve	Sunrise until Sunset

### Local Law - section 9 (1)

8. For the purposes of section 9 (1) of the Local Law no access by vehicles of any kind will be permitted in any park or reserve except for registered vehicles driven by licensed drivers on constructed roadways as designated by appropriate signage unless otherwise approved by Council.

### Local Law - section 10 (1)

9. For the purposes of section 10(i) of the Local Law and notwithstanding any other Local Law, all animals are prohibited from being brought onto a park or reserve except for dogs which may be brought onto a park or reserve only where such dog is under effective control by a person by means of a leash unless otherwise approved by Council.

### Local Law - section 15 (1)

- 10. For the purposes of section 15 (1) of the Local Law the following activities as listed below are prohibited in all parks and reserves, unless otherwise approved by Council:
  - playing golf
  - camping, occupying or residing
  - posting or fixing bills/posters/advertisements
  - discharging of firearms
  - selling food, beverages or goods
  - use of megaphones, loud speakers, or other similiar amplification equipment

### Local Law - section 19 (3)

- 11. (i) For the purposes of section 19 (3) of the Local Law the conditions that must be imposed on a licence are as follows:
  - date (s) of licence duration
  - time of licence duration
  - relevant fee, if any
  - (ii) For the purpose of section 19 (3) of the Local Law the conditions that will ordinarily be imposed in a licence are as follows:
    - The area is to be left in a clean and tidy condition after use.

- No glass containers are to be used and all cans and can ring tops are to be disposed of properly.
- No vehicles are to be driven onto the grassed areas of the park unless otherwise approved by Council.
- If any posts are erected, the holes are to be filled in.
