IPSWICH CITY COUNCIL SUBORDINATE LOCAL LAW NO. 38 – DOGS

Citation

1. This subordinate local law may be cited as Subordinate Local Law No. 38-(Dogs) 2001.

Objects

2. The objects of this subordinate local law are to provide detailed information called upon by Local Law No. 38-(Dogs) for the construction and maintenance of kennel accommodation that is required for a special permit or a kennel licence.

Local Law - section 19 – Special Permit

- **3.** For the purposes of section 19 of the Local Law all kennel accommodation provided in respect of a Special Permit is to -
 - (a) be constructed at least 3 metres from any property boundary and at least 12 metres from any residential building; and

- (b) be of sound construction and consist of materials that are impervious, weatherproof and able to be easily cleaned; and
- (c) be constructed so as to prevent a noise nuisance to any premises; and

- (d) be of sufficient size for the number, size, breed and nature of the dogs to be kept; and
- (e) provide adequate access to light and fresh air having due regard to the number, size, breed and nature of the dogs to be kept; and
- (f) provide adequate exercise and sleeping areas having due regard to the number, size, breed and nature of the dogs to be kept; and
- (g) be maintained at all times in a clean and sanitary condition; and
- (h) be maintained so that all excreta is disposed of in a nuisance free manner and is not allowed to accumulate.

Local Law – section 26 (b)- Kennel Licence

- **4.** For the purposes of section 26(b) of the Local Law all kennel accommodation provided in respect of a Kennel Licence is to -
 - (a) be of sound construction and consist of materials that are impervious, weatherproof and able to be easily cleaned; and
 - (b) be constructed so as to prevent a noise nuisance to any premises; and
 - (c) be of sufficient size for the number, size, breed and nature of the dogs to be kept; and
 - (d) provide adequate access to light and fresh air having due regard to the number, size, breed and nature of the dogs to be kept; and
 - (e) provide adequate exercise and sleeping areas having due regard to the number, size, breed and nature of the dogs to be kept; and
 - (f) be maintained at all times in a clean and sanitary condition; and
 - (g) be constructed so that all excreta is disposed via connection to sewer, septic tank or domestic aerated sewage treatment plant.

Exemptions

5. The Council or an authorised person may relax or vary any of the provisions of this Subordinate Local Law, generally or in particular cases, where the circumstances warrant such relaxation.
