


Figure 1 - Sub Plan Review Cycle

# 1.6 Key Objectives

- Identification of preparatory initiatives for the physical isolation of the community.
- Enhance response for the physical isolation of the community.

#### 1.7 Context

The risk of physical isolation following a disaster event can occur throughout the City resulting in residents being affected. The arrangements to support these residents is generally dealt with through the Local Disaster Management Plan itself. However in the instance where a whole community has a history of physical isolation and the risk of that isolation still exists (for example there has been so significant change in infrastructure for access/egress) isolated community sub plans are prepared and maintained. It is important to note these plans are supplementary



documents to local disaster management plan and the functional sub plans. Accordingly they are not intended to be the sole source of information for disaster operations and disaster recovery activities.

The emergency risk assessment for the City of Ipswich identifies that the Leichardt, One Mile and surrounding communities are at risk of isolation from flood. Whilst this plan has been prepared on that basis, an all-hazards approach has been applied wherever possible.

For planning purposes the Bundamba isolated community clusters the suburbs of **Leichhardt and One Mile** which have the potential to be impacted by the Bremer River.




Figure 2 – Leichhardt Community Boundary






Figure 3 – One Mile Community Boundary

#### PART 4: PUBLIC INFORMATION AND WARNINGS

The Public Information and Warnings Sub Plan and Council's Public Information and Warnings Manual detail Council's overall communication and warning strategy. It is however recognised that this community has particular needs related to communications.

#### 4.1 Lead Times

Flood modelling and predication is a highly complex and subjective art that relies on a range of variables and assumptions. Factors that can affect the occurrence of inundation include location, intensity and length of the rainfall; current soil and ground moisture levels; overland water flow conditions; overland flow rates; current riverine and creek levels. Council possess predictive software that its Engineers (Floodplain Management) use to provide educated predictions based on real time data and conditions. This in itself is not 100% accurate. The information of flooding provided below is extremely generalised and does not supplement or replace the knowledge and skill of trained personnel. It is provided as highly generalised, non-contextualised information and process tool.

The possible and highly indicative timeframes for effect on the community are as follows:

- Overland flows and gullies 0 to 1 hour
- Local Creeks 2 to 4 hours
- Bremer River 12 to 24 hours
- Brisbane River 48 to 72 hours

# 4.3 Community Specific Communication Strategies

Creek systems present unique challenges in determining lead time. Predictive modelling is far less accurate than that of riverine flood modelling. Council still however invests heavily in flood studies to improve this based on current industry best practice.

#### 4.3.1 Door-Knocking

Council works in partnership with the Ipswich City SES Unit to undertake door knocking in areas during events, where it is anticipated they will be directly affected by inundation. The aim is to



encourage residents to remain aware of their situation. At this time contact details of residents are obtained.

# 4.3.2 My Ipswich Alerts (Early Warning Network)

Council has engaged the Early Warning Network to provide opt-in severe and dangerous weather warnings to residents, community groups and businesses within the City.

As part of this arrangement Council is able to send custom notifications and warnings to residents that have opted in, based on their residential address or location of their mobile device. The mobile device located must have the smart phone app installed and location services switched on.



# PART 5: EVACUATION

#### 5.1 General Evacuation Information

The Evacuation Process Sub Plan and Evacuation Centre Sub Plan outline the detailed considerations and general strategies for evacuations. The below information is summarised to provide context to the more detailed information provided.

Evacuation is a risk management strategy used to mitigate the effects of an emergency on the community. It involves the movement of people to a safer location and their return. Evacuations, if unplanned, may cause greater adverse impacts than the disaster itself, including the potential to overwhelm agencies undertaking response and recovery actions. Shelter in place should be considered as an alternative where possible.

Mandatory evacuations may be ordered under the following acts:

- Disaster Management Act 2003
- Fire and Emergency Services Act 1990
- Public Safety Preservation Act 1986

It is the responsibility of the primary agency to order and control the evacuation process and overview the associated planning.




Figure 5 – Evacuation Process








Figure 1 - Sub Plan Review Cycle




Figure 2 – Marburg Community Boundary

#### PART 4: PUBLIC INFORMATION AND WARNINGS

The Public Information and Warnings Sub Plan and Council's Public Information and Warnings Manual detail Council's overall communication and warning strategy. It is however recognised that this community has particular needs related to communications.

#### 4.1 Lead Times

Flood modelling and predication is a highly complex and subjective art that relies on a range of variables and assumptions. Factors that can affect the occurrence of inundation include location, intensity and length of the rainfall; current soil and ground moisture levels; overland water flow conditions; overland flow rates; current riverine and creek levels. Council possess predictive software that its Engineers (Floodplain Management) use to provide educated predictions based on real time data and conditions. This in itself is not 100% accurate. The information of flooding provided below is extremely generalised and does not supplement or replace the knowledge, and skill of trained personnel. It is provided as highly generalised, non-contextualised information and process tool.

The possible and highly indicative timeframes for effect on the community are as follows:

- Overland flows and gullies 0 to 1 hour
- Local Creeks 2 to 4 hours
- Bremer River 12 to 24 hours
- Brisbane River 48 to 72 hours

Council works in partnership with the Ipswich City SES Unit to undertake door knocking in areas during events, where it is anticipated they will be directly affected by inundation. The aim is to



encourage residents to remain aware of their situation. At this time contact details of residents are obtained.

# 4.3.2 My Ipswich Alerts (Early Warning Network)

Council has engaged the Early Warning Network to provide opt-in severe and dangerous weather warnings to residents, community groups and businesses within the City.

As part of this arrangement Council is able to send custom notifications and warnings to residents that have opted in, based on their residential address or location of their mobile device. The mobile device located must have the smart phone app installed and location services switched on.




Figure 4 – Evacuation Process






Figure 1 - Sub Plan Review Cycle




Figure 4 – Evacuation Process






Figure 1 - Sub Plan Review Cycle




Figure 2 – Pine Mountain Community Boundary

The Public Information and Warnings Sub Plan and Council's Public Information and Warnings Manual detail Council's overall communication and warning strategy. It is however recognised that this community has particular needs related to communications.

#### 4.1 Lead Times

Flood modelling and predication is a highly complex and subjective art that relies on a range of variables and assumptions. Factors that can affect the occurrence of inundation include location, intensity and length of the rainfall; current soil and ground moisture levels; overland water flow conditions; overland flow rates; current riverine and creek levels. Council possess predictive software that its Engineers (Floodplain Management) use to provide educated predictions based on real time data and conditions. This in itself is not 100% accurate. The information of flooding provided below is extremely generalised and does not supplement or replace the knowledge, and skill of trained personnel. It is provided as highly generalised, non-contextualised information and process tool.

The possible and highly indicative timeframes for effect on the community are as follows:

- Overland flows and gullies 0 to 1 hour
- Local Creeks 2 to 4 hours
- Bremer River 12 to 24 hours
- Brisbane River 48 to 72 hours

encourage residents to remain aware of their situation. At this time contact details of residents are obtained.

# 4.3.2 My Ipswich Alerts (Early Warning Network)

Council has engaged the Early Warning Network to provide opt-in severe and dangerous weather warnings to residents, community groups and businesses within the City.

As part of this arrangement Council is able to send custom notifications and warnings to residents that have opted in, based on their residential address or location of their mobile device. The mobile device located must have the smart phone app installed and location services switched on.




Figure 4 – Evacuation Process




Figure 1 - Sub Plan Review Cycle




Figure 2 – Rosewood Community Boundary




Figure 4 – Evacuation Process

### 5.4 Livestock

In the Rosewood community it has been identified that there is a number of the population that have livestock. However, it is understood that the majority of the owners have access to properties in close proximity or have the ability to move the livestock to a suitable location should an evacuation be required. Livestock has the potential to cause havoc if left to their own devices; deceased livestock possess a risk of disease to other livestock and to neglect unnecessarily is inhumane.

However, there is a facility to accommodate livestock at the Rosewood State High School Grounds. Fencing tape to enclose livestock can be accessed through local product stores within Rosewood if required and livestock owners are responsible for all transport to and from the facility.



Each disaster event is unique and adaptations to this material will required on a case by case basis.

### 1.3 Purpose

The purpose of this document is to provide a pro-active approach to enhancing community resilience within the potentially isolated communities within the City of Ipswich.

# 1.4 Key Objectives

The key objectives of this document is to:

- Identify potentially isolated communities within the City of Ipswich
- Identify community profiles for the potentially isolated locations
- Identify key services and arrangements within each community

# 1.5 Continuous Improvement

This document will be reviewed at least annually<sup>1</sup> with relevant amendments made and distributed as needed. The review process will be in accordance with the State guidelines. Minor amendments that do not materially affect the plan are able to be authorised by the Principal Officer (Emergency Management).




Figure 1 - Continuous Improvement Cycle

# PART 2: ISOLATED COMMUNITIES OVERVIEW

The risk of physical isolation during or following a disaster event can occur throughout the City resulting in residents being affected. The arrangements to support the community is generally dealt with through the Local Disaster Management Plan itself.

In instances where a whole community has a history of physical isolation and the risk of that isolation still exists (for example there has been so significant change in infrastructure for access/egress) they are included within this sub plan

It is important to note these plans are supplementary documents to local disaster management plan and the functional sub plans. Accordingly they are not intended to be the sole source of information for disaster operations and disaster recovery activities.

### PART 3: PUBLIC INFORMATION AND WARNINGS

The Public Information and Warnings Sub Plan and Council's Public Information and Warnings Manual detail Council's overall communication and warning strategy. It is however recognised that this community has particular needs related to communications.

### 3.1 Lead Times

Flood modelling and predication is a *highly complex and subjective art* that relies on a range of variables and assumptions. Factors that can affect the occurrence of inundation include location, intensity and length of the rainfall; current soil and ground moisture levels; overland water flow conditions; overland flow rates; current riverine and creek levels. Council possess predictive software that its Engineers (Floodplain Management) use to provide educated predictions based on real time data and conditions. This in itself is not cannot be solely relied as being 100 percent accurate.



The information on possible flooding timeframes provided below is extremely generalised and does not supplement or replace the knowledge, skill of trained personnel. It is provided as a highly generalised, non-contextualised information and process tool.

The possible and highly indicative timeframes for effect on the community are as follows:

- Overland flows and gullies 0 to 1 hour
- Local Creeks 2 to 4 hours
- Bremer River 12 to 24 hours
- Brisbane River 48 to 72 hours

### 3.2 General Communication Strategies

Council employs the following communication strategies generally:

- Emergency Alert
- Emergency Broadcast
- Social Media
- Media Release
- Media Broadcast
- Website Publication



# 3.3 Community Specific Communication Strategies

Creek systems present unique challenges in determining lead time. Predictive modelling is far less accurate than that of riverine flood modelling. Council still however invests heavily in flood studies to improve this based on current industry best practice.

### 3.3.1 Door Knocking

Council works in partnership with the Ipswich City SES Unit to undertake door knocking in areas during events, where is it anticipated they will be directly affected by inundation. The aim is to encourage residents to remain aware of their situation. At this time contact details of residents are obtained.

### 3.3.2 My Ipswich Alerts (Early Warning Network)

Council has engaged the Early Warning Network to provide opt-in severe and dangerous weather warnings to residents, community groups and businesses within the City.

As part of this arrangement Council is able to send custom notifications and warnings to residents that have opted in, based on their residential address or location of their mobile device. The mobile device located must have the smart phone app installed and location services switched on.



### PART 4: EVACUATION MANAGEMENT

## 4.1 General Evacuation Information

The Evacuation Process Sub Plan and Evacuation Arrangements Manual outline the detailed considerations and general strategies for evacuations. The below information is summarised to provide context to the more detailed information provided.

Evacuation is a risk management strategy used to mitigate the effects of an emergency on the community. It involves the movement of people to a safer location and their return. Evacuations, if unplanned, may cause greater adverse impacts than the disaster itself, including the potential to overwhelm agencies undertaking response and recovery actions. Shelter in place should be considered as an alternative where possible.

Mandatory evacuations may be ordered under the following acts:

- Disaster Management Act 2003
- Fire and Emergency Services Act 1990
- Public Safety Preservation Act 1986

It is the responsibility of the primary agency to order and control the evacuation process and overview the associated planning.




Figure 3 - Five Stages of Evacuation




Figure 4 - Brassall Community Boundary




Figure 5 - North Ipswich Community Boundary




Figure 6 - Bundamba Community Boundary




Figure 8- Karalee Community Boundary




Figure 9 - Leichhardt Community Boundary




Figure 11 - Marburg Community Boundary




Figure 13 - Pine Mountain Community Boundary




Figure 14 - Rosewood Community Boundary











#### **INTRODUCTION:**

This is a report by the Ipswich Waste Services Manager dated 31 January 2019 concerning a review of the arrangement to allow Brisbane residents access to the Riverview Recycling and Refuse Centre.

#### **BACKGROUND:**

Council was approached by Brisbane City Council (BCC) in 2006 to consider an arrangement whereby Brisbane residents could access the Riverview Recycling and Refuse Centre using BCC vouchers as payment for waste disposal.

This request was declined on the basis that the facility was already operating at full capacity and any additional patrons to the site would create safety issues. A copy of the response to BCC is shown in Attachment A.

In 2008, Brisbane City Council approached Council seeking further consideration of the request. At the Council Ordinary Meeting on 16 September 2008 it was resolved:

That Council authorise the Chief Executive Officer, in consultation with Councillors, to enter into an agreement with Brisbane City Council, generally in accordance with information contained in Attachment A to the report by the Operations Coordinator, Ipswich Waste Services dated 11 September 2008, to allow specified residents access to Council's Riverview Recycling and Refuse Centre.

The above report and the subsequent agreement is contained in Attachment B.

### **CURRENT AGREEMENT:**

It should be noted that the agreement does not fully align with the 2008 Council resolution. Whilst the original discussions with Brisbane City Council appear to have been intended for residents of the suburbs transferred from Ipswich Council to Brisbane City (such as Chuwar, Karana Downs, Kholo, Lake Manchester and Mt Crosby) following a Local Government Boundary Review about ten years ago, the actual agreement between the two Councils does not refer to specified suburbs.

Brisbane City Council has been contacted on this issue and have advised that there are no restrictions on the vouchers provided to BCC residents, therefore, any Brisbane resident with a valid voucher may access and use the Riverview Recycling and Refuse Centre.

There have been no significant improvements to the Riverview Recycling and Refuse Centre since the original request was considered in 2006. Overcapacity and safety concerns, largely on weekends, continue at the site with staff continuing to manage the facility within very difficult site constraints.

The only significant issue that has occurred over the period of the agreement was unethical activity by customers presenting at the Riverview Recycling and Refuse Centre with BCC vouchers. There has been incidents where Ipswich City Council residents had purchased BCC vouchers through online platforms to save money on disposal fees. BCC vouchers are currently available for a cost of \$4.00 per visit. The staff at the Riverview Recycling and Refuse Centre have been instructed to request proof of residency in Brisbane before accepting the Brisbane Vouchers.

The following table details the number of Brisbane customers that have used the Riverview Recycling and Refuse Centre since the arrangement has commenced:

Based on the above current customer numbers average over 160 per week. However, the original expected patronage was 20-40 customers per week. A check of transactions over the past four months has indicated that 42% of these transactions are from Brisbane residents located in the original boundary review areas.

Ipswich City Council charges Brisbane City Council \$26.30 per transaction. Expected revenue from this agreement is \$219,763 for the 2018-2019 financial year.

### **DISCUSSION:**

A meeting was held with officers from Brisbane City Council's Waste Branch to determine their views on the current agreement. It was indicated that it would suit Brisbane City Council to continue with an access arrangement but they would be amenable to tighter access restrictions.

Future charging of the waste levy was also discussed. Once the waste levy commences in July 2019, Ipswich City Council will incur the \$75 per tonne waste levy charge on waste received from Brisbane residents because it will be deemed as a commercial transaction. In order to correctly on-charge Brisbane City Council for the levy charges it would be necessary for Brisbane residents to be weighed-in and weighed-out at the facility. With the current arrangement, Brisbane waste only gets weighed out if there is a suspicion that the total weight of waste would exceed 500kgs.

The following amendments to the current agreement were suggested:

- Restrict voucher use to weekdays only. This would help address Council's overcapacity concerns and enable weighing in and out of all voucher transactions.
- Align voucher use with Brisbane City Council's requirements whereby one voucher
  allows the disposal of 100kg of waste. The Riverview facility was allowing up to 500kg
  per voucher. At a Brisbane facility the resident would be required to provide five
  vouchers for a 500kg load. Weights in excess of available vouchers will be charged at
  the scheduled non-Ipswich resident waste disposal fees.
- Restrict the use of vouchers to specific suburbs of Brisbane namely Chuwar, Karana Downs, Kholo, Lake Manchester and Mt Crosby as was originally intended in the agreement.

The officers from Brisbane City Council also mentioned that they believe a significant number of Ipswich residents would be using their Willawong facility since its charges for light loads are similar to Ipswich's disposal fees. Brisbane has adequate customer capacity and is more than happy to continue to accept Ipswich residents. It was further suggested that this reciprocal arrangement could be promoted.

#### **CONCLUSION:**

There is currently an arrangement in place between Ipswich and Brisbane City Councils to allow Brisbane resident access to the Riverview Recycling and Refuse Centre. Due to overcapacity issues at the Riverview Recycling and Refuse Centre, it is proposed to apply some restrictions to the arrangement to reduce total customer numbers, limit access on weekends and align voucher use with requirements at Brisbane facilities. The staff at the Riverview facility will continue to manage customers using Brisbane City Council vouchers by requiring proof of residency through the presentation of a driver's licence or other relevant document that nominates the customers address.

Re: Brisbane Residents Access to Ipswich Waste Facilities

I have investigated the option of Brisbane residents accessing the Ipswich Waste Services Transfer Stations as outlined in your letter dated 20 March 2006.

As you have indicated the question was raised last year and subsequent discussions have occurred including a meeting between Darryl Patching from Brisbane City Works and myself. A number of issues were raised that would impact the proposal. While the option may represent a logical outcome particularly for Brisbane residents' in the Karana/Mt Crosby area it does pose significant operational problems for Ipswich Waste Services. Changes to our billing system was identified as an area to address but this does not present an impediment to the proposal. The main obstacle relates to the traffic volumes that occur at the Riverview facility.

Ipswich Waste Services operates one main Recycling and Refuse Centre (Transfer Station) at Riverview and two smaller centres at Rosewood and Peak Crossing. The smaller sites are rural facilities and cannot cater for increased volumes. Obviously the residents from Brisbane would be considering the Riverview site. Riverview is principally a facility for domestic customers although it does attract some commercial operators.

Annually some 145,000 householder transactions occur at Riverview or on average 2,800 per week. The large majority of these customers use the site on weekends with customer numbers regularly exceeding 1,000 per day on both Saturdays and Sundays. Timing of visits also impacts traffic flows with the majority of customers arriving between 10am and 3pm. Riverview has a short internal entry road which in turn results in a long line of vehicles outside the site causing major traffic disruptions in the local area. Customers can also face lengthy delays where often it can take in excess of 30 minutes to gain entry. Impacts from heavy traffic volumes are also evident inside the site where congestion occurs at the various material drop off points. In summary the Riverview facility regularly operates at peak

capacity on weekends. Therefore attracting additional vehicles to the Riverview site particularly on weekends is not desirable or appropriate.

The situation at the Riverview Recycling and Refuse Centre is not sustainable and strategies have been developed to identify alternative arrangements and to reduce traffic volumes at the site on weekends. A number of proposed changes have been identified and I anticipate these will be implemented over the next two years.

Future consideration of the proposal to allow Brisbane residents to access Ipswich Waste Services facilities may be available in the future once the traffic issues have been resolved at the Riverview site. However faced with our current operating conditions at the site this proposal does not represent a safe and workable option for Ipswich Waste Services or our customers.

#### **INTRODUCTION:**

This is a report by the Operations Coordinator Ipswich Waste Services dated 11 September 2008 concerning a proposal to allow access to the Riverview Recycling and Refuse Centre by specified residents of Brisbane City Council.

#### **BACKGROUND:**

Discussions have taken place between Officers of Ipswich and Brisbane City Councils in regard to allowing residents of the area transferred from Ipswich City to Brisbane City (Karana Downs, Mt Crosby, Kholo, Lake Manchester and part of Chuwar) in 2000 to access the Riverview Recycling and Refuse Centre. It is envisaged that there will be an increase of between twenty to forty vehicles per week attend the Riverview facility as a result of this proposal. The residents in question will be eligible to dump up to 500 Kilograms of general or green waste upon presentation of valid Brisbane City Council vouchers. Ratepayers with loads in excess of 500 kilograms will be able to use vouchers up to the limit of 500 kilograms, but thereafter will be required to pay Ipswich City Council the applicable waste disposal fee. Ipswich Waste Services will bill Brisbane City Council for the number of Waste Vouchers presented by residents on a monthly basis.

### **AGREEMENT**

for

## **ACCESS TO RIVERVIEW WASTE TRANSFER STATION**

by

## Ratepayers of Brisbane City Council's local government area

### A. Introduction

Ipswich City Council operates the Riverview Waste Transfer Station which is located within the Ipswich City Council local government area. Brisbane City Council has requested and Ipswich City Council has agreed to allow a limited number of ratepayers of the Brisbane City Council local government area to access the Facility.

The purpose of this document is to record and confirm the terms and conditions upon which Ipswich City Council agrees to allow access to the Riverview Waste Transfer Station both now and in the future.

### B. The Parties

Ipswich City Council of 45 Roderick Street, Ipswich, Queensland, hereinafter referred to as 'ICC'.

and **Brisbane City Council** of **[266 George Street, Brisbane, Queensland]** hereinafter referred to as **'BCC'**.

### C. Terms and Expressions

in this Agreement unless the context or subject matter otherwise requires:-

'Agreement' means this Agreement and the schedules and annexures hereto as amended from time to time

**'Business Day'** means any day Monday to Friday on which the national banks are open for business in Ipswich

'Facility' means the Waste Transfer Station located at Riverview Road, Riverview.

'Ratepayers' means a person who pays rates and charges to BCC

**'Statutory Charges'** means charges prescribed by legislation or awards, examples include superannuation employer contribution, payroll tax, workers' compensation, industrial awards

**'Tax Invoice'** means a document as defined in A New Tax System (Goods and Services Tax) Act and Regulations 1999

**'Voucher'** means a voucher for general waste or green waste issued to Ratepayers by BCC. {NOTE: BCC issues five (5) x 100 kg vouchers for green waste and five (5) x 100 kg vouchers for general domestic waste per annum.}

### D. Interpretation

In this Agreement unless the context or subject matter otherwise requires:-

- (a) A reference to any gender shall include all other genders.
- (b) A reference to any Clause, subclause or Schedule shall be a reference to a Clause, subclause or Schedule in this Agreement.
- (c) A reference to an agreement, deed or other document shall be read as a reference to such agreement, deed or other document as the same may from time to time be amended or modified in writing.
- (d) The singular shall include the plural and vice versa and in particular any words herein defined in the singular shall have a corresponding meaning if used in the plural and vice versa.
- (e) Reference to statutory provisions shall be construed as references to those provisions as amended or re-enacted or as their application is modified by other provisions (whether before or after the date of this Agreement) from time to time and shall include any provision of which they are re-enactments (whether with or without modification).
- (f) Any document referred to as being "in the Agreed Form" shall mean a document in a form agreed by the parties as at the date of this Agreement.
- (g) The headings herein contained are for ease of reference only and shall not in any way affect the construction of this Agreement.

### E. Terms and Conditions for Supply of Contractors

#### 1. Acceptance of Vouchers

- **1.1** ICC agrees that the Facility will accept loads of general waste and green waste up to a maximum of 500 kilograms from Ratepayers who present valid Vouchers.
- **1.2** Ratepayers with loads that are greater than 500 kilograms in weight, may use vouchers up to the limit of 500 kilograms, but thereafter will be required to pay ICC their applicable waste disposal fees.
- **1.3** Ratepayers must present valid original vouchers and also show their current BCC rates notice as proof of identification. The rates notice must be less than 12 months old. Copies of either document are not acceptable.

1.4 This Agreement applies only to domestic waste delivered by Ratepayers. Vouchers may not be presented by commercial users (for example; lawn mowing contractors, plumbers, builders). Commercial users will have to pay ICC for the disposal of waste at the Facility.

#### 2. Fees

BCC agrees to pay to ICC a fee of twenty dollars (\$20) inclusive of GST for each Ratepayer (each BCC customer) that presents Vouchers at the Facility. The fees and other matters agreed are fixed until the end of the 2008-2009 financial year.

ICC reserves the right to vary the fee agreed in the event that the State or Commonwealth governments impose a statutory charge or levy relating to landfill for which ICC becomes responsible.

#### 3. Rendering of Tax Invoices

ICC will render Tax Invoices of its fees in respect of the Vouchers monthly to BCC at such intervals as are agreed between ICC and BCC, and BCC shall pay such invoices within thirty (30) days of receipt of the Tax Invoice.

#### 4. Term

This agreement will be commence on 01 October 2008 and will remain until terminated in accordance with clause 6.

#### 5. Resolution of Disputes

If any dispute arising out of this Agreement is not resolved within 14 days of either party notifying the other party in writing that the dispute has arisen, the parties are at liberty to commence proceedings in relation to the dispute.

#### 6. Termination of Agreement

Either party may terminate this Agreement upon giving the other party two month's written notice. Notwithstanding the foregoing ICC may terminate this Agreement without notice if BCC fails to pay any amount due under Clause 3;

If this Agreement is terminated ICC shall have no liability to BCC for any loss (including loss of profits and economic loss) costs, damages, compensation or any other amount in respect of such termination.

### 7. Negation of Employment and Agency

BCC acknowledges that nothing in this Agreement constitutes any relationship of employer and employee, principal or agent or partnership between the two parties to this Agreement.

#### 8. Confidentiality

This Agreement is confidential to the parties. Neither ICC nor BCC may disclose or allow to be disclosed the contents of this Agreement to any other person except to the extent

that such disclosure is reasonably required to give effect to this Agreement or is required by law.

#### 9. Notices

Any notice, request or other communication to be given or served pursuant to this Agreement shall be in writing and addressed as the case may be, as follows:

- (i) if given to ICC, addressed and forwarded to the Chief Executive Officer, PO Box 191 IPSWICH QUEENSLAND 4305; and
- (ii) if given to BCC, addressed and forwarded to Chief Executive Officer, GPO Box 1434, Brisbane QLD 4001 [].
- (iii) Proof of posting by pre-paid mail is proof of receipt of such notice on the second clear Business Day after posting. Proof of transmission by facsimile of a notice is proof of receipt on the date of transmission but if a transmission is not made on a Business Day or not made before 4.00pm (Standard Queensland Time), then it will be deemed to have been received at 10.00am on the next Business Day after transmission.

#### 10. Other Matters

- (a) This Agreement can only be varied by agreement in writing.
- (b) Each clause in this Agreement is severable from the other clauses. If a clause or part of a clause becomes unenforceable for any reason this shall not affect the validity of the remainder of the Clause or Agreement.
- (c) If either ICC or BCC grants an extension of time or indulgence to the other party this will not operate as a waiver of any rights.
- (d) The clauses of this Agreement contain the entire agreement between ICC and BCC. BCC acknowledges that there are no promises, terms, conditions or obligations oral or written, expressed or implied, other than those contained in this Agreement.
- (e) This Agreement will be governed by the laws of the State of Queensland and the parties agree to submit to the jurisdiction of the courts of that State.
